'Spondon' Locomotive Restoration Appeal

The Society has launched an appeal for funds to allow work to progress on 'Spondon', a batteryelectric vehicle which was built in 1926 by engineers of The Derbyshire and Nottinghamshire Electric Power Company for use in their Spondon generating station. It has already been partially restored, but because it was re-gauged at some point after it left the power station it requires to be set back to its original 24" gauge. In addition the motor control system will have to be largely rebuilt from scratch, and new batteries have to be acquired. Current best estimates suggest that a total sum in the region of £10,000 will be needed to complete the project. Subject to funding availability it is believed that the locomotive could be completed within six months, after which the Society intends to arrange for it to run on an existing narrow gauge railway somewhere in the near vicinity. Donors to the appeal would thus be able see the machine working at a preview day, could ride behind it, and possibly have an opportunity to learn to drive it.
